## RELAXATION

- A relaxation of **Rs 2000.00** is offered to parents who pay the entire year's school fee in one installment by the month of April only.
- **100%** (without upgradation) & **50 %** (with upgradation) **relaxation** on the Annual Tuition Fee will be offered to students securing **10 CGPA** in Class 10 Board Examination irrespective of whether he/she is a new student, existing student, Day Scholar or Hosteller. (**Terms & Conditions Apply**)
- **Admission fee** is **waived off** in the event of parents admitting their second ward as a Day Scholars irrespective of the class.

## IMPORTANT NOTE

- Students Joining / Leaving in between the Academic Year must pay the fees for the whole year.
- The installments mentioned above should be paid on or before the due date (Latest by 20<sup>th</sup> April, 20<sup>th</sup> July, 20<sup>th</sup> October & 20<sup>th</sup> January), failing which a fine of ₹ 50.00 per day will be charged.
